Offshore Petroleum and Greenhouse Gas Storage (National Offshore Petroleum Titles Administrator) Approved Manner 2025 No. 1

Approved manner for making specified applications for the purposes of the Offshore Petroleum and Greenhouse Gas Storage Act 2006 (the OPGGS Act)

I, Graeme Albert Waters, the National Offshore Petroleum Titles Administrator (NOPTA), under subsection 33(3) of the *Acts Interpretation Act 1901* and sections 168, 255, 312, 312A, 324, 329A, 330, 335A, 336, 343, 361, 368A, 369, 426, 473, 488, 498, 525, 539, 548, 566C of the OPGGS Act,

REVOKE

- 1) any previous approvals made under subsection 168(4) of the OPGGS Act in relation to the manner of a variation of an application for a production licence by the holder of an exploration permit;
- 2) any previous approvals made under section 255(2) of the OPGGS Act in relation to the manner of a cash bid or tie-breaking cash bid application for:
 - a) the grant or renewal of a petroleum exploration permit under Part 2.2 of the OPGGS Act;
 - b) the grant or renewal of a petroleum retention lease under Part 2.3 of the OPGGS Act;
 - c) the grant, variation or renewal of a petroleum production licence under Part 2.4 of the OPGGS Act;
 - d) the grant or variation of an infrastructure licence under Part 2.5 of the OPGGS Act;
 - e) the grant or variation of a pipeline licence under Part 2.6 of the OPGGS Act;
 - f) the grant of a petroleum special prospecting authority under Part 2.7 of the OPGGS Act; and
 - g) the grant or variation of a petroleum access authority under Part 2.8 of the OPGGS Act.
- any previous approvals made under subsection 312(7) of the OPGGS Act in relation to the manner of a variation of an application for declaration of identified greenhouse gas storage formation, by a holder of a greenhouse gas assessment permit, greenhouse gas holding lease, greenhouse gas injection licence, petroleum retention lease or petroleum production licence;
- 4) any previous approvals made under subsection 312A(7) of the OPGGS Act in relation to the manner of a variation of an application for declaration of identified greenhouse gas storage formation, by a holder of a cross-boundary greenhouse gas assessment permit;
- 5) any previous approvals made under subsection 426(2) of the OPGGS Act in relation to the manner of an application for:
 - a) the grant or renewal of a greenhouse gas assessment permit under Part 3.2 of the OPGGS Act;
 - b) the grant or renewal of a greenhouse gas holding lease under section Part 3.3 of the OPGGS Act;
 - c) the grant or variation of a greenhouse gas injection licence under Part 3.4 of the OPGGS Act;
 - d) the grant of a greenhouse gas search authority under section Part 3.5 of the OPGGS Act;
 - e) the grant of greenhouse gas special authority under section Part 3.6 of the OPGGS Act;
 - f) a site closing certificate under section Part 3.4, Division 7 of the OPGGS Act;

- 6) any previous approvals made under subsection 473(2) of the OPGGS Act in relation to the manner of an application for a transfer of a title;
- 7) any previous approvals made under subsection 488(4) of the OPGGS Act in relation to the manner of an application for an approval of a dealing;
- 8) any previous approvals made under subsection 525(2) of the OPGGS Act in relation to the manner of an application for approval of transfer;
- 9) any previous approvals made under subsection 539(4) of the OPGGS Act in relation to the manner of an application for the approval of a dealing;
- 10) any previous approvals made under paragraph 566C(2)(a) of the OPGGS Act in relation to the manner of an application for approval of a change in control of the registered holder of the title;

AND

APPROVE the following manner for each of the applications specified below:

 - i) the grant or variation of a petroleum access authority under Part 2.8 of the OPGGS Act, the manner set out in **Schedule 1**.
- for the purposes of subsection 312(8) of the OPGGS Act, in relation to a variation of an application for declaration of identified greenhouse gas storage formation, by a holder of a greenhouse gas assessment permit, greenhouse gas holding lease, greenhouse gas injection licence, petroleum retention lease or petroleum production licence, the manner set out in **Schedule 5**;
- 4) for the purposes of subsection 312A(8) of the OPGGS Act, in relation to a variation of an application for declaration of identified greenhouse gas storage formation, by a holder of a cross-boundary greenhouse gas assessment permit, the manner set out in **Schedule 5**;

- 5) for the purposes of subsection 324(11) of the OPGGS Act, in relation to a variation of an application for greenhouse gas holding lease (other than a cross-boundary greenhouse gas holding lease) by the holder of a greenhouse gas assessment permit (other than a cross-boundary greenhouse gas assessment permit), the manner set out in **Schedule 5**;
- 6) for the purposes of subsection 329A(11) of the OPGGS Act, in relation to a variation of an application for cross-boundary greenhouse gas holding lease by the holder of a cross-boundary greenhouse gas assessment permit, the manner set out in **Schedule 5**;
- 7) for the purposes of subsection 330(5) of the OPGGS Act, in relation to a variation of an application for greenhouse gas holding lease (other than a cross-boundary greenhouse gas holding lease) by the holder of a greenhouse gas injection licence (other than a cross-boundary greenhouse gas injection licence), the manner set out in **Schedule 5**;
